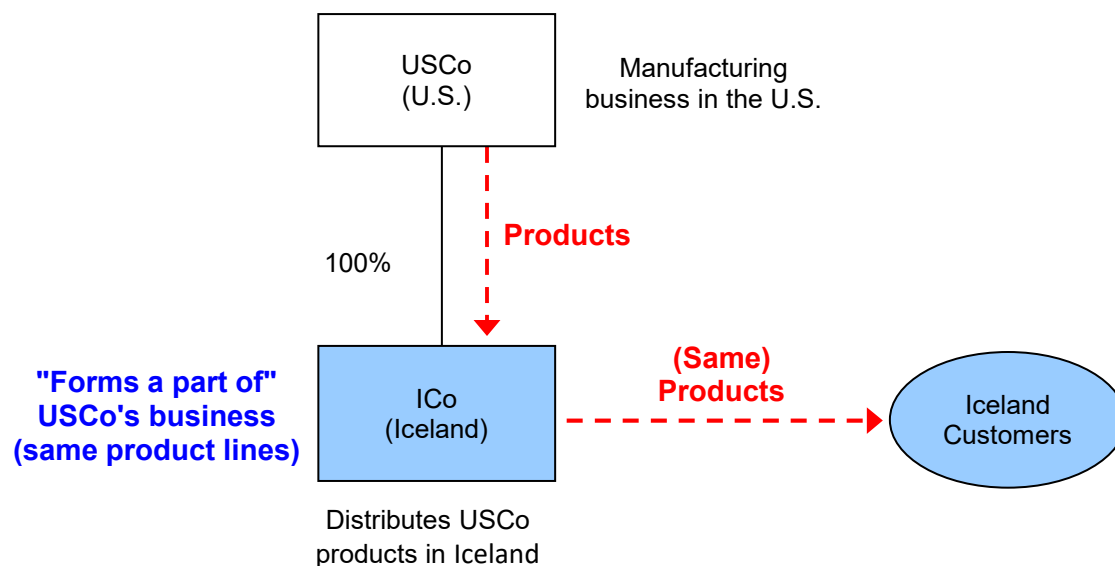

USCo is a corporation resident in the United States. USCo is engaged in an active manufacturing business in the United States. USCo owns 100 percent of the shares of ICo, a corporation resident in Iceland. ICo distributes USCo products in Iceland. Since the business activities conducted by the two corporations involve the same products, ICo's distribution business is considered to form a part of USCo's manufacturing business.
