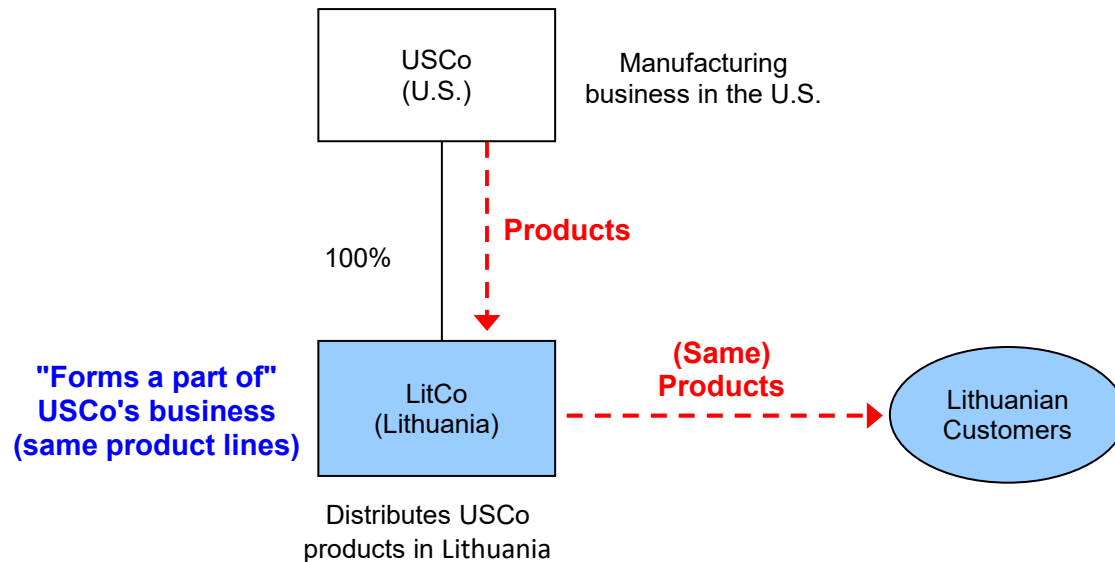

**Active trade or
business test
("derived in
connection with")**

USCo is a corporation resident in the United States. USCo is engaged in an active manufacturing business in the United States. USCo owns 100 percent of the shares of Litco, a corporation resident in Lithuania. Litco distributes USCo products in Lithuania. Since the business activities conducted by the two corporations involve the same products, Litco's distribution business is considered to form a part of USCo's manufacturing business within the meaning of subparagraph 3(d).
